Project Sister Family Services' services include a 24-hour hotline; advocacy and accompaniment to local hospitals, law enforcement interviews and legal proceedings; individual and group counseling; school-based prevention education programs for K-12 schools and college students that focus on sexual assault; child abuse prevention training for parents, teachers and other social service providers; community education; self-defense classes; an early intervention anti-violence program for pregnant and parenting teens and adults of infant and toddler children; and special programs for high-risk youth. ## **RESPONSIBILITIES:**

- Provide individual/group psychotherapy and support groups to children, adolescents, and adults.
- Clinical documentation as required.
- Respond to crisis calls during business hours as needed.
- Provide back-up support to volunteers on our 24-hour hotline in a one-week block once every 6 to 10 weeks.
- Help put together presentations for volunteer advocates training as assigned.
- Attend agency staff meetings, training and supervision as required.
- Other duties as assigned.

## QUALIFICATIONS:

- MA/MS in marriage & family counseling, MSW, PCC w/family and child classes.
- Minimum one year counseling experience, preferably with trauma victims.
- Registered with the CA Board Behavioral Sciences as an associate (we can help with this if you're not registered yet).
- Obtain agency-approved Advocate Certification (pre-license therapist/victim advocate, California evidence code, section 1035.2) and maintain annual continuing education requirements.
- Excellent verbal and writing skills.
- Ability to communicate with children, teens, adults, and seniors from diverse backgrounds.
- Ability to obtain background clearance.
- Valid California Driver's License, clean driving record, proof of insurance and reliable car.
